This excellent training is based on a multidisciplinary teaching based on 3 pillars: finance, law and taxation allowing its students to better appreciate the issues related to Financial Engineering and Corporate Finance. Master's degree is based on courses delivered by recognized professionals and academics, a rigorous selection of profiles, in a dense and dynamic network, with over 600 alumnis working at high levels of responsibility in each finance's sector.

# Complete training based on 3 pillars...

The Master 2 "Financial Engineering" of Paris 1 Panthéon-Sorbonne is a formation totalising about 400 hours of courses. Its objective is to be a specialist in high-level accounting operations, Mastering the financial aspects of these operations, while adapting to the finance's rapid reactions.

The teaching has three essential components :



AXATIO

Assessment of enterprises and equity operations; hybrid, contingent and structured financial products; option theory; international finance; the banking services market,

General tax law ; taxation of mergers and acquisitions ; fscality of derivatives ; international taxation,

• The development of a strategic and financial diagnosis of the companies allowing the implementation of relevant methods and techniques of valuation,

 Corporate valuation and reconciliation, mergers and acquisitions, LBO transactions, issuance of securities, use of hybrid financial products, equity investments in venture capital, securitization and defeasance, and the financing of projects,



Oomparative legal and tax structure ; rights of financial engineering.

These fundamental courses are complemented by more specific developments, for example in securitization operations or in the financing of local authorities.

Pedagogy, combining methodological presentations and concrete case studies, enables students to be directly involved in their assignments as soon as they take up their duties in the workplace.

Finally, an internship of an average duration of six months and the realization of a research dissertation complete this training.

• Investment Banking and Specialized Counseling (M&A, Private Equity Funds, Wealth Management, etc.) businesses,

• Study of the legal situation of the various parties involved in the transaction (shareholder agreement, more specifically clauses relating to the control of capital and the exit from an investment transaction),

• The analysis of investor tax (physical and legal persons) and tax integration mechanisms.
